

## **MOA (Memorandum of Association)**

# **FOR RISING LEAGUE INDIA**

### ***1. Name***

**The name of the Association shall be Rising League India.**

### ***2. Registered Office***

The Registered Office of the Association shall be situated at:

Qaimoh, Kulgam 192231 Jammu & Kashmir, India

### **3. Definitions**

Association means Rising League India.

Governing Body means the elected executive committee of the Association.

Member means any individual or institution admitted as per these rules.

### **4. Objectives**

The objectives of the Association shall be as laid down in the Memorandum of Association.

### **5. Membership**

Categories of Membership

General Members – Individuals interested in sports and fitness.

Student Members – School/college students registered under the Association.

Athlete Members – Sports persons actively participating in events.

Institutional Members – Schools, academies, or organizations supporting the objectives.

Honorary Members – Eminent persons nominated by the Governing Body.

Conditions for Membership

Must accept the aims & objectives of the Association.

Must follow the Rules & Regulations of the Association.

Membership may be suspended/terminated for misconduct or activities against the interest of the Association.

## **6. Admission & Fee**

Admission to membership shall be subject to approval of the Governing Body.

Membership fee (if any) shall be decided by the Governing Body from time to time.

## **7. Rights & Duties of Members**

Right to participate in meetings, programs, and activities.

Right to vote in elections (except student members below 18 years).

Duty to uphold the values of sportsmanship, discipline, and integrity.

Duty to refrain from anti-national, violent, or drug-related activities.

## **8. Governing Body Composition**

The Governing Body shall consist of not less than 7 members, including:

President

Vice President

General Secretary

Joint Secretary

Treasurer

Publicity/Media Secretary

Executive Members (3–5 as required)

Election & Tenure

Members of the Governing Body shall be elected in the General Body Meeting by majority vote.

The term of the Governing Body shall be 3 years.

Office bearers are eligible for re-election.

#### **9. Powers & Functions of the Governing Body**

To manage and control all affairs of the Association.

To admit, suspend, or remove members.

To raise funds, manage accounts, and approve budgets.

To organize sports leagues, tournaments, and programs.

To collaborate with institutions, federations, and government bodies.

To frame additional rules, policies, and codes of conduct.

#### **10. Powers & Duties of Office Bearers**

##### *President*

Head of the Association and Preside over all meetings.

Represent the Association at Official Levels.

##### *Vice President*

Assist the President and Act in his/her absence.

##### *General Secretary*

Chief Executive Officer of the Association.

Maintain Records, Correspondence, and Call Meetings.

##### *Joint Secretary*

Assist the Secretary and Handle Delegated Work.

### *Treasurer*

Maintain Accounts, Prepare Budgets, and Manage Funds.

### *Publicity/Media Secretary*

Handle Promotions, Publications, and Social Media Activities.

### *Executive Members*

Assist in Programs and Decision-making.

## **11. General Body.**

The General Body shall consist of all members of the Association.

It shall meet once a year in an Annual General Meeting (AGM).

It shall elect the Governing Body and approve major decisions.

## **12. Meetings.**

Governing Body meetings shall be held at least once every 3 months.

General Body shall meet annually or as required.

Quorum:

Governing Body – 1/3rd of its members.

General Body – 1/5th of its members.

## **13. Finance.**

The funds of the Association shall consist of:

Membership Fees, Donations, Grants, Sponsorships, and Event Revenues.

All funds shall be deposited in a scheduled Bank Account in the Name of the Association.

Joint signatures of the President, General Secretary, Joint Secretary, and Treasurer shall operate the Bank Account.

**14. Audit.**

Accounts of the Association shall be maintained properly and audited annually by a qualified auditor appointed by the Governing Body.

**15. Amendment of Rules.**

Any amendment to the Memorandum or these Rules shall be made by a 2/3rd majority vote of the General Body and subject to approval of the Registrar of Societies.

**16. Dissolution.**

In the event of dissolution of the Association, its assets and liabilities shall be disposed of as per the Memorandum of Association (Clause VIII).

**17. Jurisdiction.**

The jurisdiction of the Association shall extend to the whole of India, with a focus on Jammu & Kashmir.
